I did not think anyone would support or believe me.
I had asked online for help as to how to proceed and no one believed me, and said that I was “lucky”.
I resolved it on my own
I wasn't aware that it was sexual assault until several months later. There was no logical way for me to prove that it happened, so I decided to move on. Also, I didn't know how to report it at the time.

was not successful
